6. PERT/CPM



**Contract Agreement Form for the
Regravelling, Improvement of Various Barangay Roads
Barangay Calombuyan, Victoria, & Macaycayawan, Sual, Pangasinan**

CONTRACT AGREEMENT

This Agreement, made this 24th day of November, 2025 between **Municipality of Sual, Pangasinan** (hereinafter called "the Entity") and **Georavin Construction & Supplies** (hereinafter called "the contractor") of the other part.

Whereas, the Entity is desirous that the **Regravelling, Improvement of Various Barangay Roads at Barangay Calombuyan, Victoria, & Macaycayawan, Sual, Pangasinan** (hereinafter called "the Works") and the Entity has accepted the Bid for **Four Million One Hundred Ninety-Five Thousand Six Hundred Nineteen Pesos and Seventy-One Centavos Only (Php. 4,195,619.71)** by the contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS :

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Regulations of Implementing Rules and Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Addenda and/or Supplemental/Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto;
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of Four Million One Hundred Ninety-Five Thousand Six Hundred Nineteen Pesos and Seventy-One Centavos Only (Php. 4,195,619.71) or such other sums as may be ascertained, Georavin Construction & Supplies agrees to execute and complete the Works and remedy any defects therein in accordance with his/her/its Bid.
4. The Municipality of Sual, Pangasinan agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


