Invitation to Bid for
CONSTRUCTION OF POTABLE WATER SYSTEM LEVEL 3
at Poblacion and Baybay Sur, Sual, Pangasinan

1. The **Municipal Government of Sual, Pangasinan**, through the 2026 20% Development Fund intends to apply the lump sum bid of **Php. 7,499,878.71** being the Approved Budget for the Contract (ABC) to payments under the contract **Early Procurement Activity (EPA) of Construction of Potable Water System Level 3 at Poblacion and Baybay Sur, Sual, Pangasinan** with the following project components with corresponding project cost.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Municipal Government of Sual, Pangasinan** now invites bids **Construction of Potable Water System Level 3 at Poblacion and Baybay Sur, Sual, Pangasinan**. Completion of the Works is required 360 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2020 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Municipal Government of Sual, Pangasinan and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M. .
5. A complete set of Bidding Documents may be acquired by interested bidders on December 19, 2025 to January 19, 2026 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php. 10,000.00**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Municipal Government of Sual, Pangasinan** will hold a Pre-Bid Conference on **2:00 P.M., January 5, 2026** at **G/F, Conference Room, BAC Office, Municipal Hall Building**,

Poblacion, Sual, Pangasinan, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **2:00 P.M., January 19, 2026**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **2:00 P.M., January 19, 2026** at **/F, Conference Room, BAC Office, Municipal Hall Building, Poblacion, Sual, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Bidding of the above-mentioned projects shall be conducted **“Short of Award”** pending the approval of the General Appropriations Act FY 2026.
9. Whereas, Section 7.6 of the 2016 revised IRR of RA No. 9184 states that “to facilitate the immediate implementation of procurement of Goods, Infrastructure Projects or Consulting Services, even pending approval of the General Appropriations Act (GAA), corporate budget or appropriations ordinance, as the case may be, and notwithstanding Section 7.2 hereof, the procuring entity (PE) may undertake the procurement activities short of award. xxx No award of contract shall be made until the GAA, corporate budget or appropriations ordinance, as the case may be, has been approved or enacted”;
10. The **Municipal Government of Sual, Pangasinan** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
