Invitation to Bid for
CONSTRUCTION OF ONE-UNIT CLASSROOM BUILDING
at Batidape, Sitio Baito, Poblacion, Sual, Pangasinan

1. The **Municipal Government of Sual, Pangasinan**, through the 2025 Special Education Fund (Supplemental Budget) intends to apply the lump sum bid of **Php. 1,908,097.26** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of One-Unit Classroom Building at Batidape, Sitio Baito, Poblacion, Sual, Pangasinan** with the following project components with corresponding project cost. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Municipal Government of Sual, Pangasinan** now invites bids **Construction of One-Unit Classroom Building at Batidape, Sitio Baito, Poblacion, Sual, Pangasinan**. Completion of the Works is required 90 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2020 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Municipal Government of Sual, Pangasinan and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M. .
5. A complete set of Bidding Documents may be acquired by interested bidders on December 24, 2025 to January 21, 2026 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php. 5,000.00**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Municipal Government of Sual, Pangasinan** will hold a Pre-Bid Conference on **2:00 P.M., January 6, 2026** at **G/F, Conference Room, BAC Office, Municipal Hall Building, Poblacion, Sual, Pangasinan**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **2:00 P.M., January 21, 2026**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **2:00 P.M., January 21, 2026** at **G/F, Conference Room, BAC Office, Municipal Hall Building, Poblacion, Sual, Pangasinan**. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **Municipal Government of Sual, Pangasinan** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
