CONTRACT FOR SUPPLY AND DELIVERY OF RICE ASSISTANCE TO INDIGENT INDIVIDUALS OR FAMILIES at Sual, Pangasinan

This CONTRACT executed on the 22nd day of May, 2026 by and between:

Municipal Government of Sual, Pangasinan, a government agency of the Republic of the Philippines, hereinafter called "the Entity";

-and-

Maawi Alos Farmers Multipurpose Cooperative a company duly organized and existing under the laws of Republic of the Philippines, with principal office at Tangarang, Alaminos City, Pangasinan, hereinafter called "the Supplier/Contractor/Consultant".

WHEREAS, the Entity invited Bids for certain goods and services/works/consulting services, particularly the **Supply and Delivery of Rice Assistance to Indigent Individuals or Families at Sual, Pangasinan**;

WHEREAS, the Supplier/Contractor/Consultant submitted a responsive bid and was awarded the contract for the procurement in the total amount of **Four Million Nine Hundred Ninety-Nine Thousand Four Hundred Pesos Only (P 4,999,400.00)**, hereinafter referred to as the "Contract Price."

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 and the guidelines for the Procurement of Agricultural and Fishery Products under Republic Act No. 11321, or the "Sagip Saka Act", shall form part and be read and construed as integral parts of this Contract, viz.:
 - a. For Procurement of Goods
 - i. Request for Proposal;
 - ii. Terms and Conditions;
 - iii. Schedule of Requirements;
 - iv. Documentary Requirements;
 - Duly Accomplished Proposal Form
 - FFEDIS Certificate of Registration or proof of registration or accreditation on RSBSA
 - Or any Department of Agriculture (DA) - approved registry/accreditation system
 - v. General and Special Conditions of Contract;
 - vi. Supplemental Bid Bulletins, if any; and
 - vii. Other contract documents that may be required by existing laws and/or the Entity.
 - b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Notice of Award of Contract; and the Bidder's Conforme thereto; and
 - d. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Republic Act No. 11321, or the "Sagip Saka Act" and under Negotiated Procurement – Sagip Saka (NP-SS), such as but not limited to the Notice to Proceed.
3. In consideration of the Contract Price of **Four Million Nine Hundred Ninety-Nine Thousand Four Hundred Pesos Only (P 4,999,400.00)** other sums as may be determined in accordance with the terms of the Contract, the Supplier/Contractor/Consultant agrees to deliver and perform the items and related services for the **Supply and Delivery of Rice Assistance to Indigent Individuals or Families at Sual, Pangasinan** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4. The **Municipal Government of Sual, Pangasinan** agrees to pay the above-mentioned sum to the Supplier/Contractor/Consultant in accordance with the schedule and manner provided in the guidelines under R.A. No. 11321.
5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).

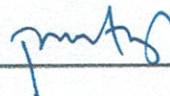
